Notification No. 35/2024-25 New Delhi, Dated: 1 October 2024

Subject: Amendment in Export Policy condition of Cough Syrup under Chapter 30 of Schedule-II (Export Policy) of ITC (HS) 2022-reg.

In exercise of powers conferred by Section 3 read with section 5 of the Foreign Trade (Development & Regulation) Act, 1992, read with Para 1.02 and 2.01 of the Foreign Trade Policy 2023, as amended from time to time, and in continuation of the Notification No. 06/2023 dated 22.05.2023, the Central Government amends the Export Policy condition for HSN 3004 under Chapter 30, Schedule-II (Export Policy) of ITC(HS) 2022, with immediate effect as under:

- Oasis Test House, 24-A, B (ii) In case, the manufacturers are exporting the Cough Syrup to USA, UK, Canada, EU, Estate, Narol, Ahmedabad-Japan, Australia, Singapore, Republic of Korea and Switzerland, the requirement of testing from the laboratories mentioned at (i) above may be waived off, in view of approval granted by these countries' regulatory agencies for plants/section engaged in manufacturing and export of Cough Syrup.
 - (iii) Further, if Cough Syrup is manufactured in a plant/section approved by the regulatory agencies for above mentioned countries at (ii) for any product, such Cough Syrup shall be permitted to be exported to any country without testing as mandated at (i) above.

Effect of this Notification: The mandatory testing of the export sample of 'Cough Syrup' under HSN 3004 is exempted in certain situations as mentioned above in accordance with the required GMP benchmarks/standards.
