S.O (E): In exercise of the powers conferred by Section 3 read with Section 5 of the Foreign Trade (Development & Regulation) Act 1992, read with Para 1.02 and 2.01 of the Foreign Trade Policy 2023, as amended from time to time, the Central Government hereby amends the following Export policy condition under Chapter 17 of Schedule-II (Export Policy), ITC (HS) 2022 with immediate effect:

iii. Submission of requisite test reports and certification from NABL accredited laboratories confirming compliance with Pharma Grade Sugar specifications at the time of actual exports.

Effect of This Notification: Export of Pharma Grade Sugar, up to a total of 25,000 MTs per financial year, shall be permitted to Bonafide Pharma Exporters against a Restricted Export Authorisation.
